

#	Туре	Question	Response
1	General	If more than one proposal is accepted, will work packages be split? How will collaboration between the successful providers work?	Only one proposal will be accepted
2	General	How will the selection process work? Will only CT select or in collaboration with the OWA Partners?	CT and OWA Partners will make a joint decision based on scoring according to tender criteria
3	Project Specific	What is the expected timeline for delivery of the project?	For this project the expected timeline is 10-12 months
4	Project Specific	Who do you expect to tender?	We expect a broad range of participants that fulfil the criteria of relevant expertise and experience. We welcome bids from individuals, companies, organisations or consortia
5	Project Specific	Is this project intended to be an academic/scientific or commercial project?	This project is the first of its kind on this theme within the OWA, as such the project should be both a combination of an academic/scientific and commercial approaches.
6	Project Specific	How are the OWA Partners expected to use this insight?	This is dependent on the OWA partner, but it is expected that this work may lay the foundation for future project work as well as allow partners to potentially review their corporate processes and assumptions at a subsequent stage.
7	Project Specific	The project is targeted at resource variations. Can we assume extreme risk is less relevant?	Resource variations are the main focus, but if insight can be gained into extreme conditions from the same dataset then the bidder may include this as an optional task and explain their proposed methodology.

8	Project Specific	What is meant by "establish limitations"?	This refers to defining the limitations to the methodology itself
9	Project Specific	How are high wind speeds defined?	Definition of high wind speeds is open to interpretation and the TWG are happy to lean on the contractor to define these
